

SEPA ENVIRONMENTAL CHECKLIST

Purpose of checklist:

Pump would be available for non consumptive use year-round and would be used as needed to support management of ESA-listed fish, and fish produced as mitigation for construction and operation of Columbia River dams.

WDFW seeks to acquire permits and refurbish the existing river pump station to allow for river water use up to 10 CFS for non-consumptive fish propagation. Previous use of Columbia River water at the facility was found to be unauthorized and was discontinued pending permitting approval from Ecology. Existing infrastructure is likely to require replacement, though current electrical and discharge piping can likely be used.
