EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal years 2009, 2010, or 2011, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: The closure will reduce incidental hooking mortality on wild steelhead. The 2009/2010 forecasted return of wild winter steelhead to the Puyallup River system is expected to be below the escapement goal of 2,000 fish. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 232-28-61900V Exceptions to statewide rules—Puyallup, Carbon and White (Stuck) Rivers.

Notwithstanding the provisions of WAC 232-28-619, effective February 18, 2010, until further notice it is unlawful to fish in the following waters:

- (1) Puyallup River from the 11th St. Bridge in Tacoma upstream to Electron Power Plant Outlet.
- (2) Carbon River from the mouth to Voights Creek.
- (3) Carbon River from Voights Creek to Hwy.162 Bridge.
- (4) White (Stuck) River from the mouth to R Street Bridge in Auburn.
