EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal years 2009, 2010, or 2011, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this for this finding: The US Army Corps of Engineers has coordinated with many partners to provide a fishing event for kids from several elementary classrooms in the Tri-Cities. Closing Hood Park Pond before the event will eliminate premature harvest of catchable-size trout dedicated to the youth fishing event. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 232-28-61900X Exceptions to statewide rules—Hood Park Pond.

Notwithstanding the provisions of WAC 232-28-610, effective 8:00 a.m. April 16 through 1:00 p.m. April 17, 2010, it is unlawful to fish in waters of Hood Park Pond, except open to juvenile anglers.
