EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal years 2009, 2010, or 2011, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: The U.S. Geological Survey river flow gage towers and cableway that currently comprise the downstream sturgeon spawning sanctuary boundary line are in the process of being dismantled and removed. A new boundary line is required to implement the sturgeon spawning sanctuary this year. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 232-28-61900X Exceptions to statewide rules—Columbia River sturgeon.

Notwithstanding the provisions of WAC 232-28-619, effective May 1 through July 31, 2010, it is unlawful to fish for sturgeon from the boundary marker on the river bank 400 feet downstream of the Priest Rapids Hatchery outlet channel (Jackson Creek), to Priest Rapids Dam.
