Reasons for this finding: Enactment of a 15 fish daily limit for shiner perch will provide a basis for orderly recreational fisheries while providing increased conservation benefits for this species compared to earlier years. The department intends to develop proposals for a permanent rule change. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 220-56-24000F Daily limits forage fish and other food fish not otherwise provided for.

Notwithstanding the provisions of WAC 220-56-240, effective May 1, 2010 until further notice, in those waters of Catch Record Areas 1 through 11 and Catch Record Area 13, the daily limit for shiner perch is 15.
