Allowing fishing on Wednesday instead of Friday would eliminate this problem. The fishery is governed by quota, so the overall harvest is not affected by this request. NEW SECTION

**WAC 220-48-01500A Beam trawl and bottom trawl—Seasons.**

Notwithstanding the provisions of WAC 220-48-015, effective immediately until further notice, it is unlawful to fish for or possess bottomfish for commercial purposes with otter trawl gear in Marine Fish-Shellfish Management and Catch Reporting Area 23C on Fridays, Saturdays and Sundays.
