NEW SECTION

WAC 232-28-61900C Exceptions to statewide rules—Black River (Thurston Co.)

(1) Notwithstanding the provisions of WAC 232-28-619, effective June 5 through September 30, 2010, a person may fish for gamefish in waters of the Black River from the mouth of Black Lake and all tributaries west of I-5, including Waddell Creek, Mima Creek, Dempsey Creek, Beaver Creek, Salmon Creek and Blooms Ditch, under the following provisions:

(a) Trout – Daily limit 2, minimum size 14 inches in length. Selective gear rules in effect. Internal combustion motors prohibited.

(b) Other game fish – Statewide rules and selective gear rules in effect. Internal combustion motors prohibited.

REPEALER

The following section of the Washington Administrative Code is repealed effective October 1, 2010:

WAC 232-28-61900C Exceptions to statewide rules—Black River (Thurston Co.)

EMERGENCY RULE ONLY

Under RCW 34.05.350 the agency for good cause finds:

(x) That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
