NEW SECTION

WAC 232-28-61900U Exceptions to statewide rules—South Fork Stillaguamish River

Notwithstanding the provisions of WAC 232-28-619, effective June 5 through September 30, 2010, a person may fish for gamefish in waters of the South Fork Stillaguamish River from the Mountain Loop Highway Bridge above Granite Falls, upstream. Catch-and-release, except two hatchery steelhead may be retained. Selective gear rules are in effect and fishing from a floating device with a motor is prohibited. Effective August 1 through September 30, 2010, night closure is in effect.

REPEALER

The following section of the Washington Administrative Code is repealed effective October 1, 2010:

WAC 232-28-61900U Exceptions to statewide rules—South Fork Stillaguamish River.
