NEW SECTION

**WAC 232-28-61900N Exceptions to statewide rules—Clarks Creek (Pierce Co.)**

Notwithstanding the provisions of WAC 232-28-619, effective August 1 through October 31, 2010, a person may fish for game fish in waters of Clarks Creek from the mouth of Clarks Creek upstream to 12<sup>th</sup> Ave. SW. Daily limit of two trout over 14 inches in length; statewide minimum size and daily limits apply for all other game fish. Release wild steelhead and selective gear rules in effect.

REPEALER
