EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal years 2009, 2010, or 2011, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this for this finding: The invasive species New Zealand Mudsnaill is present in the lake and Mudsnaills are easily transported on shoes, boots, and fishing gear to which they may attach themselves it is necessary to close the lake. The lake has already been closed to salmon angling. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 232-28-61900B Exceptions to statewide rules—Capitol Lake.

Notwithstanding the provisions of WAC 232-28-619, effective September 3, 2010, until further notice, it is unlawful to fish in waters of Capitol Lake.

EMERGENCY RULE ONLY

Under RCW 34.05.350 the agency for good cause finds:

(x) That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.

() That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.

() That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal years 2009, 2010, or 2011, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: The invasive species New Zealand Mudsail is present in the lake and Mudsails are easily transported on shoes, boots, and fishing gear to which they may attach themselves it is necessary to close the lake. The lake has already been closed to salmon angling. There is insufficient time to adopt permanent rules.
