NEW SECTION

**WAC 232-28-61900I Exceptions to statewide rules—Kalama River.**

Notwithstanding the provisions of WAC 232-28-619, effective September 20 through December 31, 2010, it is unlawful to retain Chinook salmon in waters of the Kalama River From boundary markers at the mouth to 1000 feet below the fishway at the upper salmon hatchery.

REPEALER

The following section of the Washington Administrative Code is repealed effective January 1, 2011:
