NEW SECTION

WAC 220-47-31100E Puget Sound purse seine fishery.

Notwithstanding the provisions of WAC 220-47-311 and WAC 220-47-500, it is permissible for the vessels "Polarland" and "Josie J" to participate in the Purse seine fishery in Puget Sound Salmon Management and Catch Reporting Area 8A on September 27 and October 4, 2010.

REPEALER

The following section of the Washington Administrative Code is repealed effective October 5, 2010:

WAC 220-47-31100E Puget Sound Purse seine fishery.
