NEW SECTION

WAC 232-28-61900M Exceptions to statewide rules—Tilton River.

Notwithstanding the provisions of WAC 232-28-619, effective October 1 through December 31, 2010, it is unlawful to fish in waters of the Tilton River from the mouth to West Fork from one hour after official sunset to one hour before official sunrise.

REPEALER

The following section of the Washington Administrative Code is repealed effective January 1, 2011:

WAC 232-28-61900M Exceptions to statewide rules—Tilton River.
