EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal years 2009, 2010, or 2011, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: The closure will reduce incidental hooking mortality on wild steelhead. The expected return of wild winter steelhead to the Samish River is well below escapement goals. Puget Sound steelhead were listed under the federal Endangered Species Act as of May 2007. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 232-28-61900C Exceptions to statewide rules—Samish River.

Notwithstanding the provisions of WAC 232-28-619, effective December 1, 2010, until further notice, it is unlawful to fish in waters of the Samish River from the I-5 Bridge to the Hickson Bridge.

EMERGENCY RULE ONLY
