EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal years 2009, 2010, or 2011, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: The Nooksack River wild steelhead run is depressed and will not meet the spawning goal for the 2010/2011 return year. These closures will reduce the incidental hooking mortalities of wild steelhead. Puget Sound wild steelhead populations are listed as "Threatened" under the Endangered Species Act. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 232-28-61900P Exceptions to statewide rules—Nooksack River.

Notwithstanding the provisions of WAC 232-28-619:

- (1) **Nooksack River mainstem:** From the Lummi Indian reservation boundary to the confluence of the North and South forks: Closed to all fishing, effective February 1, 2011.
- (2) **North Fork Nooksack River:** From the mouth to Maple Creek: Closed to all fishing, effective February 16, 2011.
- (3) **North Fork Nooksack River:** From Maple Creek to Nooksack Falls: Closed to all fishing, effective February 1, 2011.
- (4) **Middle Fork Nooksack River:** From the mouth to City of Bellingham diversion Dam: Closed to all fishing effective February 1, 2011.
- (5) **South Fork Nooksack River:** From the mouth to Skookum Creek: Closed to all fishing, effective February 1, 2011

EMERGENCY RULE ONLY

Under RCW 34.05.350 the agency for good cause finds:

(x) That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.

() That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.

() That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal years 2009, 2010, or 2011, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.
