EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal years 2009, 2010, or 2011, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: The commercial non-Indian sea cucumber harvest quota share in District 1, the San Juan Island area, is nearing exhaustion. In order to allow continued harvest opportunity and ensure that the area harvest quota is not exceeded, sea cucumber District 1 will close, effective Wednesday, April 6, 2011. Sea cucumber landings reported from District 5, the South Puget Sound area, are sufficient to keep this area open. Districts 2, 3 and 4 remain closed for the 2010-2011 harvest management period. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 220-52-07100I Sea Cucumbers.

Notwithstanding the provisions of WAC 220-52-071, effective 12:01 a.m. April 6, 2011, until further notice, it is unlawful to take or possess sea cucumbers taken for commercial purposes except as provided for in this section:

(1) Sea cucumber harvest using shellfish diver gear is allowed in Sea Cucumber District 5, seven days per week.
