NEW SECTION

WAC 232-28-61900D Exceptions to statewide rules—Hoh River.

Notwithstanding the provisions of WAC 232-28-619, effective May 14 through May 15, 2011 a person may fish for salmon and gamefish in the following waters:

- (1) Hoh River - from the mouth to the Olympic National Park boundary below the mouth of the South Fork Hoh.
- (2) South Fork Hoh River – from its mouth to the Olympic National Park boundary.

REPEALER

The following section of the Washington Code is repealed effective May 16, 2011:

WAC 232-28-61900D Exceptions to statewide rules—Hoh River.
