EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: This regulation implements agreement between the Department and treaty tribes to reduce conflict and confusion regarding boundaries. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 232-28-62100M Puget Sound salmon--Saltwater seasons and daily limits.

Notwithstanding the provisions of WAC 232-28-621, WAC 220-56-128, and WAC 220-56-195, effective September 5, 2011, through October 15, 2011, it is unlawful to violate the following provisions, provided that unless otherwise amended, all permanent rules remain in effect:

1) **Catch Record Card Area 7:**

- a. Waters east of a line from Gooseberry Pt. to Sandy Pt., closed.

REPEALER

The following section of the Washington Administrative Code is repealed effective 12:01 AM October 16, 2011:

WAC 232-28-62100M Puget Sound Salmon – Saltwater seasons and daily limits. (11-223)

EMERGENCY RULE ONLY

Under RCW 34.05.350 the agency for good cause finds:

Reasons for this finding: This regulation implements agreement between the Department and treaty tribes to reduce potential conflict between recreational anglers and tribal fishers. There is insufficient time to adopt permanent regulations. **(11-223, 9/2/2011)**
