NEW SECTION

**WAC 220-47-31100R Purse seine—Open periods.**

Notwithstanding the provisions of WAC 220-47-311:

- (1) It is unlawful to take, fish for, or possess salmon taken for commercial purposes with purse seine gear in waters of Puget Sound Salmon Management and Catch Reporting Areas 12, 12B and 12C.
- (2) It is unlawful to take, fish for, or possess salmon taken for commercial purposes with purse seine gear in waters of Puget Sound Salmon Management and Catch Reporting Areas 10 and 11.

NEW SECTION

**WAC 220-47-41100Z Gill net--Open periods.**

Notwithstanding the provisions of WAC 220-47-411, it is unlawful to take, fish for, or possess salmon taken for commercial purposes with gill net gear in waters of Puget Sound Salmon Management and Catch Reporting Areas 12, 12B, and 12C.
