EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: This rule change is necessary to assure a successful Kids Fishing event. The fish will be planted in the lake two days prior to the event to better acclimate them. On the day of the event, only children 14 years of age and under will be allowed to fish in the lake. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 232-28-61900R Exceptions to statewide rules—Heart Lake (Skagit Co.)

Notwithstanding the provisions of WAC 232-28-619, effective 12:01 a.m. May 30 through June 2, 2012, it is unlawful to fish in those waters of Heart Lake, except open to fishing 6:00 a.m. to 12:00 p.m. June 2, 2012, to anglers participating in the youth fishing event. Juvenile anglers can continue to fish on June 2, 2012, after the youth fishing event closes.

REPEALER

The following section of the Washington Administrative Code is repealed effective 12:01 a.m. June 3, 2012:

WAC 232-28-61900R Exceptions to statewide rules—Heart Lake (Skagit Co.)

EMERGENCY RULE ONLY

Under RCW 34.05.350 the agency for good cause finds:

(x) That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.

() That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.

() That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal years 2009, 2010, or 2011, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: This rule change is necessary to assure a successful youth fishing event. The fish will be planted in the lake two days prior to the event to better acclimate them. On the day of the event only juvenile anglers will be allowed to fish in the lake. There is insufficient time to adopt permanent rules.
