NEW SECTION

WAC 232-28-61900W Exceptions to statewide rules—Humptulips River.

Notwithstanding the provisions of WAC 232-28-619, effective immediately through November 30, 2012, in waters of the Humptulips River from Ocean Beach Road to the Highway 101 Bridge, the daily limit is six salmon, of which no more than three may be adult salmon, and of the three adult salmon, only one may be a Chinook and only one may be a wild coho.

REPEALER

The following section of the Washington Administrative Code is repealed effective December 1, 2012:

WAC 232-28-61900W Exceptions to statewide rules—Humptulips River.
