EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: This emergency rule is necessary to ensure a safe and successful youth fishing event. Five thousand trout will be planted three days prior to the event to acclimate them and ensure they bite well. On April 27, 2013, pre-registered kids will be allowed to fish during the event. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 232-28-61900T Exceptions to statewide rules—Sarg Hubbard Park Pond (Reflection Pond).

Notwithstanding the provisions of WAC 232-28-619, effective 12:01 a.m. April 24, through 4:00 p.m. April 27, 2013, it is unlawful to fish in Sarg Hubbard Park Pond, except as provided in the sections below:

- (a) Open to fishing 9:00 a.m. to 4:00 p.m. April 27, 2013, by juvenile anglers participating in the Yakima Greenway Association's "Kids' Fish-In" event.
- (b) The daily limit is reduced to two trout during the youth fishing event.

REPEALER

The following section of the Washington Administrative Code is repealed effective 4:01 p.m. April 27, 2013:

WAC 232-28-61900T Exceptions to statewide rules—Sarg Hubbard Park Pond.

EMERGENCY RULE ONLY
