Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

NEW SECTION

WAC 232-28-61900X Exceptions to statewide rules—Nooksack river.

Notwithstanding the provisions of WAC 232-28-619, effective January 9 through January 31, 2014, it is unlawful to fish in the following waters:

- (1) The Nooksack River from the mouth to the confluence of the North and South Forks.
- (2) The South Fork Nooksack from the mouth to Skookum Creek.
- (3) The Middle Fork Nooksack from the mouth to city of Bellingham diversion dam.
- (4) The North Fork from the mouth to Nooksack Falls.

REPEALER

The following section of the Washington Administrative Code is repealed effective February 1, 2014:

WAC 232-28-61900X Exceptions to statewide rules.

EMERGENCY RULE ONLY

Under RCW 34.05.350 the agency for good cause finds:
