EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: As of June 2, a total of 225 adult spring chinook have returned to Klickitat Salmon Hatchery. Klickitat Salmon Hatchery is expected to meet its escapement goal of 500 fish which will allow additional recreational opportunity. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 220-310-18500I Freshwater exceptions to statewide rules—Klickitat River.

Notwithstanding the provisions of WAC 220-310-185, effective June 7 through July 31, 2014:

- (1) It is permissible to fish in waters of the Klickitat River from 400 feet upstream of the #5 fishway to boundary markers below the Klickitat Salmon Hatchery.
- (2) Daily limit 6 salmon, of which no more than 2 may be adults. Release wild Chinook.

REPEALER

The following section of the Washington Administrative Code is repealed effective August 1, 2014:

WAC 220-310-18500I Freshwater exceptions to statewide rules—Klickitat River.
