Reasons for this finding: Washington Department of Fish and Wildlife planted 20,000 hatchery winter steelhead smolts into Rock Creek in the spring of 2013, these fish will provide for a recreational winter fishery by extending the season. There is insufficient time to adopt permanent rules.

NEW SECTION

**WAC 220-310-18500M Freshwater exceptions to statewide rules—Southwest.**

Notwithstanding the provisions of WAC 220-310-185, effective November 1, 2014, until further notice, it is permissible to fish in waters of Rock Creek from the mouth upstream to the falls. Unless otherwise amended, all permanent rules remain in effect.
