NEW SECTION

**WAC 220-47-41100F Gillnet--Open periods.**

Notwithstanding the provisions of WAC 220-47-411, effective immediately until further notice, it is unlawful to take, fish for or possess salmon taken for commercial purposes with gillnet gear in Puget Sound Salmon Management and Catch Reporting Areas 10 and 11 except that the areas are open to commercial gillnet fishing for salmon from 4:00 p.m. November 25 to 8:00 a.m. November 26, 2014.
