- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: This rule change is necessary to ensure a safe and successful event. The fish will be planted one day prior to the event to better acclimate them before the event. On the days of the event, only pre-registered kids will be allowed to fish. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 220-310-18000P Exceptions to statewide rules—Lake Sylvia (Grays Harbor Co.)

Notwithstanding the provisions of WAC 220-310-180, effective 6:00 p.m. June 5 through 5:59 a.m. June 6, 2015, it is unlawful to fish in waters of Lake Sylvia.

REPEALER

The following section of the Washington Administrative Code is repealed effective 6:00 a.m. June 6, 2015:

Reasons for this finding: This rule change is necessary to ensure a safe and successful event. The fish will be planted one day prior to the annual kid's fishing derby to better acclimate them before the event. On the day of the event, only pre-registered kids will be allowed to participate in the derby but Lake Sylvia is open to fishing for everyone. There is insufficient time to adopt permanent rules.
