NEW SECTION

**WAC 220-310-19000X Exceptions to statewide rules—Long’s Pond
(Thurston Co.)**

Notwithstanding the provisions of WAC 220-310-190, effective 12:01 a.m. June 12, 2015, it is unlawful to fish in those waters of Longs Pond, except as provided in this section:

- (1) Open to fishing 6:00 a.m. to 2:00 p.m. June 12, 2015, to anglers participating in the Puget Teacher Student Organization, Special Services K-12 Fishing Event.
- (2) Statewide rules apply.

REPEALER

The following section of the Washington Administrative Code is repealed effective 2:01 p.m. June 12, 2015:

WAC 220-310-19000X Exceptions to statewide rules—Longs Pond (Thurston Co.)

EMERGENCY RULE ONLY

Under RCW 34.05.350 the agency for good cause finds:

(x) That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.

() That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal years 2009, 2010, 2011, 2012 or 2013 which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: This rule change is necessary to ensure a safe and successful Kids Fish-In event; the Shelton School District Special Services DD Program as hosted by the Lacey Community Center, Lacey, WA. There is insufficient time to adopt permanent rules.
