- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: An emergency rule is needed to close the Sea Urchin commercial fishery as the end of the 2014-15 Sea Urchin management period is August 31, 2015. The commercial Sea Urchin fishery will revert to the permanent Washington Administrative Code.

The following section of the Washington Administrative Code is repealed September 1, 2015:

WAC 220-52-07300R Sea Urchins. (15-212)

EMERGENCY RULE ONLY

Under RCW 34.05.350 the agency for good cause finds:

() That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal years 2009, 2010, 2011, 2012 or 2013 which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: An emergency rule is needed to close the Sea Urchin commercial fishery as the end of the 2014-15 Sea Urchin management period is August 31, 2015. The commercial Sea Urchin fishery will revert to permanent the Washington Administrative Code. (15-288, 8/27/2015)
