- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: The continued presence of summer chinook in the lower Hoh River necessitates extending the current protections for this depressed stock, including releasing all chinook, and requiring selective gear to discourage targeting of chinook. These requirements will remain in place until river flows increase sufficiently to enable the summer chinook to move up river. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 220-310-18000Z Freshwater exceptions to statewide rules—Coastal.

Notwithstanding the provisions of WAC 220-310-180, effective September 1, 2015, until further notice, it is unlawful to violate the provisions below. Unless otherwise amended, all permanent rules remain in effect.

Hoh River – From the DNR Oxbow Campground boat launch downstream to the Olympic National Park boundary near the mouth of the Hoh River.

- (1) Selective gear rules apply.
- (2) Release Chinook salmon.

EMERGENCY RULE ONLY
