**WAC 220-47-31100T Purse seine--Open periods.**

Notwithstanding the provisions WAC 220-47-311, effective immediately through November 30, 2015, it is unlawful to fish for, or possess salmon taken for commercial purposes with purse seine gear in Puget Sound Salmon Management and Catch Reporting Areas 12, 12B and 12C.

NEW SECTION

**WAC 220-47-41100N Gillnet--Open periods.**

Notwithstanding the provisions of WAC 220-47-411, effective immediately through November 30, 2015, it is unlawful to fish for, or possess salmon taken for commercial purposes with gillnet gear in Puget Sound Salmon Management and Catch Reporting Areas 12, 12B and 12C.
