EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: Coho broodstock needs at the Sol Duc Hatchery have been met, and a late move of coho up the Sol Duc River has resulted in surplus hatchery (adipose fin clipped) coho in the Sol Duc River below the hatchery. This action extends the salmon season by allowing anglers to retain hatchery coho through December 15, 2015. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 220-310-18000L Freshwater exceptions to statewide rules—Coast.

Notwithstanding the provisions of WAC 220-310-180, effective December 1 through December 15, 2015, it is permissible to fish in the waters of the Sol Duc River downstream of the hatchery.

Salmon: Daily limit of two hatchery coho, release wild coho and Chinook. Minimum size 12 inches.

REPEALER

The following section of the Washington Administrative Code is repealed effective December 16, 2015:

WAC 220-310-18000L Freshwater exceptions to statewide rules—Coast.

EMERGENCY RULE ONLY

Under RCW 34.05.350 the agency for good cause finds:
