EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: Restrictions are needed on the Stillaguamish River to ensure broodstock needs for early winter steelhead are met at the Whitehorse Hatchery. No early winter hatchery steelhead smolt have been released from the Whitehorse Hatchery since 2013. This year's hatchery return is forecast to be less than 400 fish. Approximately 120 broodstock are needed to meet egg take goals. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 220-310-19000R Freshwater exceptions to statewide rules—Puget Sound.

Notwithstanding the provisions of WAC 220-310-190, effective December 7, 2015, through January 31, 2016, selective gear rules in effect and catch and release of all steelhead in the following waters:

- (1) Stillaguamish River from Marine Drive upstream to the forks.
- (2) North Fork Stillaguamish River from the mouth to Swede Heaven Bridge.

REPEALER

The following section of the Washington Administrative Code is repealed effective February 1, 2016:

EMERGENCY RULE ONLY

Under RCW 34.05.350 the agency for good cause finds:

(x) That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.

() That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.

() That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal years 2009, 2010, 2011, 2012 or 2013 which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: Restrictions are needed on the Stillaguamish River to ensure broodstock needs for early winter steelhead are met at the Whitehorse Hatchery. No early winter hatchery steelhead smolt have been released from the Whitehorse Hatchery since 2013. This year's hatchery return of early winter steelhead is forecast to be 22% of recent year average. There is insufficient time to adopt permanent rules.
