The following section of the Washington Administrative Code is repealed effective December 25, 2015:

WAC 220-310-19000T Freshwater exceptions to statewide rules—Puget Sound. (15-438)

EMERGENCY RULE ONLY

() That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal years 2009, 2010, 2011, 2012 or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: An emergency rule is needed to lift the restrictions which were put in place with emergency rule WSR 16-01-004 as the Kendall Creek Hatchery and Whatcom Creek Hatchery programs have met egg take needs. There is insufficient time to adopt permanent rules. **(15-452, 12/23/2015)**
