EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: This emergency rule will rescind selective gear rules and catch and release only in Anderson Lake (Jefferson Co.) and will open the lake year round with freshwater statewide rules in effect. Lifting these restrictions and opening the lake year round under freshwater statewide rules will provide additional angling opportunity. The Department of Fish and Wildlife will be filing a preproposal statement to begin the permanent rule process.

WAC 220-310-18000Z Freshwater exceptions to statewide rules-Coastal.

Notwithstanding the provisions of WAC 220-310-180, effective October 1, 2016, until further notice, it is permissible to fish in waters of Anderson Lake (Jefferson County). The following rules apply:

- (1) Statewide freshwater rules are in effect.
- (2) Selective gear rules are rescinded.
- (3) Trout: Catch and release is rescinded.
