EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: Washington Department of Fish and Wildlife and tribal co-managers agreed to a limited number of chinook encounters retaining or releasing fish that anglers are allowed in Marine Areas 8-1, 8-2, 9, and 10. This emergency rule is needed to modify these fisheries to stay within the agreed to number of encounters and increasing the possibility of providing season-long fisheries which will provide additional angling opportunity. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 232-28-62100M Puget Sound salmon—saltwater seasons and daily limits.

Notwithstanding the provisions of WAC 232-28-621, it is unlawful to violate the provisions below. Unless otherwise amended, all permanent rules remain in effect.

- (1) **Marine Areas 8-1 and 8-2:** Effective November 1, 2016, until further notice:
 - (a) Daily limit of 2 salmon, no more than 1 Chinook. Release coho and wild Chinook.

- (2) **Marine Area 9:** Effective November 1 through November 30, 2016:
 - (a) Daily limit of 2 salmon, no more than 1 Chinook. Release coho and wild Chinook.

- (3) **Marine Area 10:** Effective November 1, 2016, until further notice:
 - (a) Daily limit of 2 salmon, no more than 1 Chinook. Release coho and wild Chinook.

REPEALER

The following section of the Washington Administrative Code is repealed effective December 1, 2016:

WAC 232-28-62100M Puget Sound salmon—saltwater seasons and daily limits.
