**EMERGENCY RULE**

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: This emergency rule is needed to close the recreational crab fishery in Marine Area 10 to stay within harvest shares. The other marine areas may remain open through December 31, 2016 seven days per week providing harvest opportunity. Available harvest shares allow these areas to remain open according to this rule. There is insufficient time to adopt permanent rules.

## NEW SECTION

### **WAC 220-56-33000B Crab—Areas and seasons.**

Notwithstanding the provisions of WAC 220-56-330, effective November 16 through December 31, 2016, it is permissible to fish for crab for personal use seven days a week in Marine Areas 4 east of the Bonilla-Tatoosh line, 5, 6, 7, 8-1, 8-2, 9, and 12.
