I would like to request that the Naselle River, upstream of the Highway 4 Bridge to 400 foot below the hatchery attraction chanel, be opened to sport fishing August 1.

I have contacted a number of riverfront land owners, land owners and citizens that frequent our community to get their opinion regarding a early opener. (See enclosed signatures). The overall response was positive. Some had been convinced in the past that it was out of the question. However I heard comments like: It's about time!, It' never made sense to have it closed anyway!, I never understood why it was closed., it really makes good sense to open it and make good use of our natural resource. Only one landowner opposed opening early. His main concern was snagging, however we have been assured by local Fish and Game management staff that they will address the problem if it occurs.
