Management guidelines, allocations, and run forecasts for the 2007 fall season were presented in the Fall Fact Sheet #1 (July 26, 2007)

STOCK STATUS

Fall Chinook

- Bonneville Dam adult Chinook passage through September 26 totals 130,200 fish, including 114,700 brights and 15,500 tules.
- TAC's September 24 updated run sizes include 118,500 URBs and 17,000 BPH at the Columbia River mouth. Modeling suggests the URB run may be a little higher.
- McNary Dam adult Chinook passage totals 37,000 fish (Aug. 9- Sep. 25). Daily passage has significantly increased over the last few days. Passage is about 75% complete by September 25. TAC is reasonably confident that the escapement goal of 43,500 fish will be reached.
- The Spring Creek hatchery escapement goal of 4,000 females will not be met. An estimated 2,700 females are in the hatchery and daily returns are around 200-300 total fish a day.

Steelhead

- Bonneville Dam steelhead passage (Jul 1- Sep 26) totals 295,250 fish. Total passage (July-Oct) is generally 92% complete by September 26. The preseason forecast was 297,900 fish, including 241,500 Group A and 56,400 Group B fish.
- TAC's September 17 updated run sizes include 290,000 Group A fish (63,800 wild) and 22,000 Group B fish (6,600 wild).

Coho

- At Bonneville Dam, all coho passing through September are considered early stock coho. Bonneville Dam passage through September 26 totals 59,900 adults. Passage is about 93% complete. Preseason expectations totaled 79,200 early stock coho at Bonneville Dam. The 50% upriver coho escapement requirement under *US v Oregon* is expected to be met.

Gear:	9-inch minimum mesh size and 9¾-inch maximum mesh size	
The following regulations apply to all fisheries listed above:		
Sanctuaries:	As applicable: Elokomin-B, Abernathy, Cowlitz, Kalama-B, Lewis-B, Sandy, and Washougal rivers	
Allowable Sales:	Salmon and white sturgeon. A maximum of 7 white sturgeon may be possessed or sold by each participating vessel during each calendar week (Sunday through Saturday) that the fishery is open. Limit applies to mainstem only. The weekly white sturgeon limit in Select Areas remains at 5 white sturgeon for each participating vessel during each calendar week (Sunday through Saturday).	
Miscellaneous Rules:	<p>Multiple Net Rule: It will be legal to have onboard a commercial vessel more than one net as long as the nets are of legal size for the fishery, or the net has a minimum mesh size of 9 inches, and the length of any one net does not exceed 1,500 feet in length.</p> <p>Nets not specifically authorized for use in the fishery may be onboard the vessel if properly stored. A properly stored net is defined as a net on a drum that is fully covered by a tarp (canvas or plastic) and bound with a minimum of ten revolutions of rope with a diameter of 3/8 (0.375) inches or greater.</p> <p>24 hour Quick Reporting Rules will be in effect for Washington buyers. Buyers must report within 24 hours of each fishery closure</p>
