REPORTING

Completed Annual reports must be received by the WDFW Wildlife Program **no later than April 20** of each year, regardless of whether you trapped or not.

*Include all target and non-target species captured. If the species caught was your target species, mark “Y” for Yes. If the species was a non-target capture, or incidental capture, mark “N” for No.

Recreational Trapper: Trapping season, November 1 – March 31.

As per Washington Administrative Code (WAC), all trappers purchasing a trapping license must report their trapping activity, regardless of trapping success or whether they trapped or not. Trappers must report trapping activity by April 20. Reports must be made using Washington Department of Fish and Wildlife (WDFW) designated Recreational Trapper or Wildlife Control Operator Annual Report form. If a trapper chooses to report using the Recreational Trapper and Wildlife Control Operator Annual Report form, it is the responsibility of the licensed trapper to obtain the most current form (<http://wdfw.wa.gov/hunting/trapping/>) and ensure the form is received by WDFW by April 20. Any trapper not reporting on time or knowingly reporting false or misleading information will be in non-compliance with reporting requirements. **Noncompliance is an infraction**, punishable under RCW 77.15.160.

Wildlife Control Operator (WCO): Reporting period, April 1 of the previous year through March 31 of the current reporting year.

Per WAC, WCOs, regardless of trapping success or whether they trapped or not, must submit a complete annual report of all WCO-related activity. **Failure to submit a report may result in revocation of the WCO certification** and denial of future certifications. Reports must be made using the WDFW designated Recreational Trapper or Wildlife Control Operator Annual Report form. It is the responsibility of the WCO to obtain the most current form (http://wdfw.wa.gov/living/nuisance/how_to_become_wco.html) and ensure the form is received by WDFW by April 20.
