DETERMINATION OF NONSIGNIFICANCE

Name of Proposal: WDFW SE WASHINGTON DISTRICT 3 RECREATIONAL DAM
MODIFICATION OR REMOVAL

Description of Proposal: People recreating on both public and private lands are building recreational dams for fun or to create swimming or wading pools. These dams often are large enough, or tall enough to block fish passage, especially during low summer stream flows. All anadromous salmonids in SE WA are listed as Threatened under ESA. It is critical that fish passage in streams be maintained. The proposal is to have an existing HPA for SE WA that would permit fisheries or habitat program staff, WDFW enforcement officers, or Wildlife Area managers to remove or modify recreational dams to re-establish fish passage. Large numbers of these recreational dams are found each summer. This would allow these to be dealt with effectively, efficiently, and in a timely manner. All work to modify or remove the dams would be done by hand or with hand tools.
