During the 2009 flood event, the precast concrete Armorflex sections of the White Bridge Access area were damaged on the upstream side. Quarry spalls were washed out from underneath the boat ramp. Damages will be repaired by replacing Armorflex concrete block mats in sections measuring 6 foot x 13 feet and 4.5 feet by 30 feet. Riprap (8.89 Cubic Feet) will be used to replace the washed out quarry spalls in an area measuring 30 feet long x 4 feet wide x 1 foot deep on the upstream side of the boat launch. An additional area (13 feet long x 4 feet wide x 14 inches deep) will be repaired on the upstream side (shoulder) of the boat ramp with 2.25 cubic yards of dirt fill.

The proposed project site is within the White Bridge Access area on the Wynoochee River in Grays Harbor County. To reach this site continue west from Montesano .9 mi on Hwy 8, exit at Wynoochee Lake-Devonshire Rd. Proceed north on Wynoochee Valley Rd 11.7 miles. Turn left at public fishing sign and continue approximately .5 mi on dirt road to the end. This project is located at Section 28, Township 19N, and Range 8 West.

3% slope.

Soils in the vicinity are classified as Riverwash with 7% Juno Sandy Loam.

- d. Are there surface indications or history of unstable soils in the immediate vicinity? If so, describe.** No.

- e. Describe the purpose, type and approximate quantities of any filling or grading proposed. Indicate source of fill.**

This site will have 8.89 cubic yards of riprap installed underneath the Armorflex sections of the boat launch. The riprap will come from a local quarry.

- f. Could erosion occur as a result of clearing, construction or use? If so generally describe.**

Yes, replacement of the boat ramp sections and placement of the riprap and fill dirt will temporarily disturb the boat ramp surfaces.

g. About what percent of the site will be covered with impervious surfaces after project construction (for example, asphalt or buildings)?

There will be no increase in impervious surfaces at this site.

h. Proposed measures to reduce or control erosion, or other impacts to the earth, if any:

Erosion impacts will be reduced by placing a sediment barrier around the construction sites to isolate the disturbed area from surface waters.

2. Air

Low levels of vehicle exhaust emissions and dust from construction activities are expected during project activities. No long-term effects in air quality are anticipated to result from the completed project.

The Wynoochee River is at the project site. The Wynoochee River is connected to Grays Harbor.

2) Will the project require any work over, in, or adjacent to (within 200 feet) the described waters? If yes, please describe and attach available plans.

Yes, all components are directly adjacent to the Wynoochee River (see attached plans).

3) Estimate the amount of fill and dredge material that would be placed in or removed from surface water or wetlands and indicate the area of the site that would be affected. Indicate the source of fill material.

The White Bridge boat launch on the Wynoochee River will require 8.89 cubic yards of riprap, and two sections of Armorflex boat ramp (6 foot x 13 feet and 4.5 feet by 30 feet) to repair damaged areas within the existing structure. The riprap will be placed under the repaired boat launch sections. The side of the boat launch will have 2.25 yards of dirt fill placed at the upper end of the boat launch sections. The majority of these materials will be under OHW; however they will be installed during approved work windows in low flow conditions. These materials will be purchased from a local quarry.

Yes, the entire site is within the (A Zone) 100-year floodplain.

Stormwater in the area sheet flows from impervious road surfaces onto adjacent river bank areas and is infiltrated before reaching surface waters. This project will not change storm water runoff patterns.

Endangered species are known to occur near this site in the Wynoochee River. These include coho (ESU: Lower Columbia River), and Bull Trout (Historic).

Salmon and trout migrate through this area including; Chinook, coho, chum, and steelhead. Historically bull trout migrated through this area. Juvenile Coho salmon and most likely utilize the Wynoochee River as overwinter rearing habitat.

Structures on this site include a vault toilet and small parking area.

No recreational activities will be displaced. Access to the boat launch and wildlife area will be preserved.
