MITIGATED DETERMINATION OF NONSIGNIFICANCE (MDNS)

Name of Proposal: VISTA VILLAGE-GRASSCARP-PRIVATE POND

Description of Proposal: Plant triploid (sterile) grass carp into an unnamed pond, with no public access, to control aquatic vegetation. Future restocking may be necessary due to fish loss.

The proponent/applicant shall incorporate the following mitigation measures into the project:

1. All inlets and/or outlets shall be fully screened prior to planting grass carp to prevent fish from emigrating out of the pond.

Lead Agency: Washington Department of Fish and Wildlife (WDFW)

WDFW has determined that this proposal will likely not have a significant adverse impact on the environment. Therefore, state law¹ does not require an environmental impact statement (EIS).
