DETERMINATION OF NONSIGNIFICANCE (DNS)

Name of Proposal: WOODRIFF DITCH MAINTENANCE

Description of Proposal: Washington DOT has cleaned out sediment covering culverts along WA Hwy 164 to allow water to flow into woodruff ditch (August 2010) Now one to two feet of sediment and reed canary grass will be cleaned out of a man-made Woodriff ditch to complete restoration of water flow.
