### DETERMINATION OF NONSIGNIFICANCE (DNS)

**Name of Proposal:** CARIBOU CREEK FISH PASSAGE PROJECT

**Description of Proposal:** Project is a joint project of Kittitas County Conservation District and Washington Department of Fish and Wildlife.

A concrete and wooden irrigation dam will be removed to restore fish passage in Caribou Creek with implementation of this project. The dam was used to divert irrigation water via gravity flow down an unscreened, unmetered, and unlined ditch. Irrigation improvement projects have converted the property to a pressurized piped system directly from Ellensburg Water Company's main canal and the gravity diversion and associated dam is no longer necessary.

**Lead Agency:** Washington Department of Fish and Wildlife (WDFW)

WDFW has determined that this proposal will likely not have a significant adverse impact on the environment. Therefore, state law<sup>1</sup> does not require an environmental impact statement (EIS). WDFW made this determination of nonsignificance (DNS) after we reviewed the environmental checklist and other information on file with us.

We issued this DNS according to state rules.<sup>2</sup> We will **not act on this proposal for 14 days** from the date we issued the DNS. Agencies, affected tribes, and members of the public are invited to comment on this proposal or DNS. We must receive your comments within 14 days of the date of this letter. This means we must receive your comments by **August 28, 2013**.
