### DETERMINATION OF NONSIGNIFICANCE (DNS)

**Name of Proposal:** DNS 15-004: BARN PIPE TIDEGATE REPLACEMENT

**Description of Proposal:**

The proposed project will replace a tidegate that drains agricultural fields within the Skagit Wildlife Area Estuary Unit. The tidegate does not function properly and the dike is eroding. A setback dike will be built with the current dike being removed near project completion. A new 30" by 68' culvert will be installed under the new dike with a combination gate on the estuary side of the dike. Some contour grading of the estuary outlet will be done to create a more even flow channel.

**Location of Proposal, including street, if any:** Skagit Wildlife Area on Fir Island, 21961 Wylie Road, Mount Vernon, Skagit County, Washington: Township 33N, Range 3E, Section 25.

**Lead Agency:** Washington Department of Fish and Wildlife (WDFW)

WDFW has determined that this proposal will likely not have a significant adverse impact on the environment. Therefore, state law<sup>1</sup> does not require an environmental impact statement (EIS). WDFW made this determination of nonsignificance (DNS) after we reviewed the environmental checklist and other information on file with us.

We issued this DNS according to state rules.<sup>2</sup> We will **not act on this proposal for 14 days** from the date we issued the DNS. Agencies, affected tribes, and members of the public are invited to comment on this proposal or DNS. We must receive your comments within 14 days of the date of this letter. The comment period will end at **5:00 pm on January 30, 2015**.
