Comments: Recon surveyed on Wednesday March 23rd with Mr. Lund. Located at 210 Lund Lane, Cle Elum, WA. This is a small three quarter acre pond oriented in the uplands south of Nelson Siding Road between Big & Little Creeks but above flood prone areas. The pond has been in place for 25+ years. The pond water source is from ground water and an inlet valve from an irrigation ditch on the property. The outlet is a screened standpipe that flows out to an irrigated pasture. There is no possibility of grass carp escape from the pond which has an abundance of Northern Milfoil and other aquatic vegetation. The applicant indicated that aquatic vegetation continues to grow and become a nuisance throughout the summer. The pond contained stocked rainbow trout. I recommend a maximum stocking density of only 12 triploid grass carp to achieve long term control of aquatic vegetation at a minimum of 8 inches in total length. The fish must be obtained from a Washington state finfish supplier and certified as disease free.




MAP OF LAKE OR POND
