Starting at Forks, drive north on highway 101 to MP 197.6. There is a gravel road off to the left just before a shake mill. Turn left onto the road and proceed about 0.3 mi to second stream crossing. This is Loushin Cr. Follow Loushin Creek upstream on the left bank for 30 m to S-312R-03.




