- Jan. 11: State open north of Klipsan to DI
- Jan. 15: State open DI to U.S./Canada border.



Early Season Projections

- We knew early on that 2021-2022 would be a high abundance season
 - Landings in the first 30 days were the highest they've been since 2012-2013
- We know that in high abundance seasons the state is likely to catch more than 50%



Inseason management

Inseason management principles

- Early check-ins so that measures can be implemented early enough to be effective
- Consideration for meaningful measures in line with imbalances in harvest sharing
- Considered management measures for two primary reasons:
 - Actual end of season harvest sharing in previous high abundance seasons such as 2016-2017 and 2012-2013 which appear to be most similar to this season and shows the state could exceed 50 percent at the end of the season
 - Uncertainty in state catch data due to the unusually high number of fish ticket changes in state-QIN co-managed areas





In-season Action - March

Starting March 4, 2022, WDFW modified the QIN SMA (adding 70 sq miles) by;

- Moving the southern boundary approximately 2 miles south,
- Maintaining the northern boundary at Raft River,
- Extending the western boundary to 30 fathoms.





Continued Check-Ins

- Review catch and sharing in March and April
- Potential adjustments based on actual catch data
- No additional inseason changes were made
- Uncertainty in state catch data due to the unusually high number of fish ticket changes in state-QIN co-managed areas



Impacts to 2022-2023 State-QIN Discussions

- Catch data is fundamental to harvest sharing responsibilities
- WDFW does not change fish tickets, but we do check for errors and inconsistencies
- Ongoing investigation
- QIN has requested a formal report
 - What is the actual catch???
- Discussion elevated to the Director
- Unsure what Quinault's response will be
