Background

WAC 220-352-245 - requires guides to fill out logbooks for each guided trip. Data recorded:

- Date
- Guide license #
- Water body fished
- Customer angler WILD ID, paid or comped
- crew members WILD ID if fishing
- species encountered life stage, hatchery vs wild



Implementation and Communication with Guide Industry

2017

 Numerous meetings with guides to discuss legislation and hear from industry on potential regulation changes

2019

- WAC 220-352-245 passed
- Guide Advisory Committee established
- Agency develops, tests and deploys reporting tools (mobile, web, paper)
- Info to guides during license renewal process


2020

- January 2020 rule goes into effect
- COVID guide restrictions in place
- Closures and fisheries restrictions in key guide fisheries

2021 - 2022

Education and emphasis patrols to increase contacts and compliance

What we're learning from the data

- Industry trends
 - Key fisheries and areas used by guides
 - Frequency at which individual guides take trips
 - Length of trips and number of trips taken by guides in a day
- Guide customer trends
 - Percentage of WA licensed anglers using guides to access fisheries
 - Prevalence of repeat customers

Logbook WAC Revision Proposal

- Require trip info to be entered at the start of fishing day
- Take out reference to vessel, boat launch to clarify that it's required by all guides
- Remove web reporting option
- Increase paper logbook return to twice monthly
 - Trips taken 1-15th day of month due 28th
 - Trips taken 16th end of month due 14th of next month

- October 19 CR 102 filed
- Public comment period open

December

- December 9 Presentation, public comment
- December 10 Public comment closed

January

 January 13 - Review public comment, review and approval of revised rule
